

APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE

The undersigned (hereinafter called the 'Applicant') hereby applies for membership in and for electric service from Lyon-Lincoln Electric Cooperative, Inc. (hereinafter called the 'Cooperative'), and agrees to purchase electrical power at the location shown below, upon the following terms and conditions.

1. The Applicant will pay the Cooperative the sum of \$5.00, which if this Applicant is accepted by the Cooperative, will constitute the Applicant's membership fee.
2. The Applicant will comply with and be bound by the provisions of the Articles of Incorporation and By-laws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative.
3. The Applicant agrees that the use of this electric service will be in compliance with all applicable building and zoning ordinances and that the Cooperative may ask that proper evidence of compliance with permit provisions of such ordinances be furnished prior to the time electric service is connected.
4. The Applicant will cause his premises to be wired in accordance with wiring specifications approved by the Minnesota State Board of Electricity and agrees to maintain all wiring, motors, and electrical apparatus so that it will be safe to use and will not interfere with service to other consumers on the system.
5. The Applicant will, when electric service becomes available, make all electric power purchases on the premises described below from the Cooperative and will pay therefore in accordance with the prevailing rate schedules of the Cooperative.
6. The Cooperative will have the right of access to the Applicant's premises at all times for the purpose of installing, reading, inspecting, repairing, replacing or removing any meters, devices, or other equipment or material which is the property of the Cooperative and to keep line area clear of all buildings, structures or other obstructions, trees, shrubbery, undergrowth and roots. The Cooperative will have the right of ingress and egress over the lands for purpose of collecting outstanding financial obligations due the Cooperative.
7. The Applicant agrees that he will not knowingly perform any act which will interfere with or endanger the installed electrical system; and that he will not dig, excavate or grade in area where underground facilities are installed without the consent of the Cooperative.
8. The Cooperative shall not be liable for the interruption of power caused by acts of God, strikes, or circumstances beyond its control.
9. All first-time membership applications for residential service shall require a security deposit of \$100.00 prior to connection of service. After 12 months of a good credit history, this deposit shall be paid back to the member in full. Interest on this money will be paid as required by law.
10. Should the Cooperative be required or requested to read a member's meter, a meter reading fee shall be charged as set per Board Policy.
11. The applicant hereby understands that 50 cents/month of the amount paid for electricity is for a subscription to The Cooperative Newsletter.
