LLEC encourages you to conserve energy in your home and at work. By participating in our energy efficiency programs, you can keep costs down and earn rebates when you install led lighting equipment.

- **General Qualifications**

- Retrofit systems must result in a net load reduction in kW usage from that of the existing lighting system.
- Rebate applies to indoor lighting retrofit programs only. Rebates will not be given for outdoor lighting.
- Rebates will be given directly to the members and will not be given to Lighting Suppliers or Contractors.

- **Application—Limited Funds**

- This program is offered from January 1 through December 31 of the respective calendar year. Rebate requests are processed on a “first-come first-serve” basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time. The customer is responsible for checking with Lyon-Lincoln Electric Cooperative to determine whether the program is still in effect.
- The minimum rebate application is \$50.00 & maximum rebate amount is \$2,000 per customer per calendar year based on 30 cents/watt saved up to 50% of LED costs.

- **Inspection and Verification**

- The Cooperative reserves the right to conduct inspections of any and all installations. One sample of each type of old lamp or ballast must be retained for at least 90 days. If the cooperative finds that the customer has not complied with its rules and standards, any rebated the customer has received must be returned to the cooperative.

- **Equipment Eligibility Requirements**

- All equipment must be new and meet specification requirements.

- **Tax Information**

- The Cooperative will not be responsible for any tax liability imposed as a result of the rebate payments. Consumers are advised to consult their tax advisors before submitting rebate requests.

- **Disclaimer**

- The Cooperative gives no warranties, expressed or implied, with respect to equipment operation, material, workmanship or manufacturing. The Cooperative does not guarantee that the implementation of energy-efficient measures or use of equipment purchased or installed pursuant to this program will result in energy or cost savings. In no event shall the Cooperative be liable for any incidental or consequential damage. The Cooperative is not responsible for the disposal of lamps and/or ballasts replaced as a result of this program.

- Rebates will not be given for equipment or designs that do not comply with local, state or federal regulations.
- The Cooperative is not liable for rebates promised to a customer as a result of a contractor misrepresenting the program.
- Customers must apply for rebates within a year of the purchase date shown on the equipment invoice.
